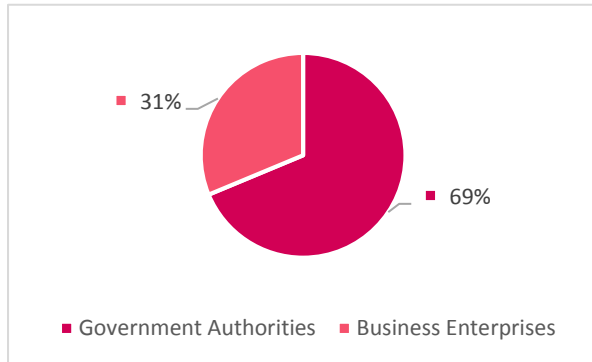

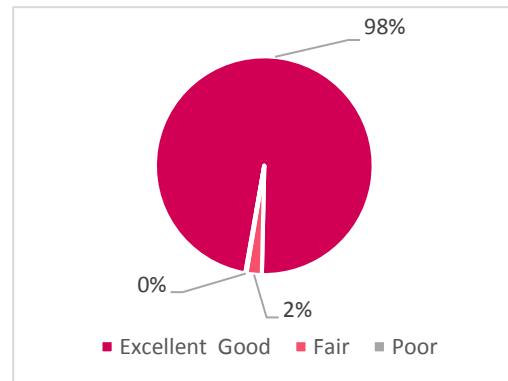


## Statistics of 2016
